The undersigned is directed to say that NLCIL had submitted Progressive Mine Closure Monitoring and Audit reports of the Second phase conducted by IEST, Shibpur regarding reimbursement of claims under progressive Mine closure Plan of Mines of NLCIL as mentioned in Annexure -I for an amount of **RS. 162,27,33,600/- (One Hundred Sixty Two Crore Twenty Seven Lakh Thirty Three Thousand Six Hundred Rupees Only)**. After scrutiny of documents submitted by NLCIL and inspection report submitted by CCO-HQ level Inspection Committee, the Technical Committee of CCO (HQ), had recommended for reimbursement of **Rs. 139,52,87,066/- (One Hundred Thirty Nine Crore Fifty-Two Lakh Eighty-Seven Thousand and Sixty-Six Rupees Only)** for the said projects. Amount of **Rs. 139,52,87,066/- (One Hundred Thirty Nine Crore Fifty-Two Lakh Eighty-Seven Thousand and Sixty-Six Rupees Only)** is to be released as per the new guidelines issued by M/o Coal dated 29<sup>th</sup> May 2020.
