Notice

The undersigned is directed to say that WCL had submitted Final Mine Closure Monitoring and Audit reports of the Final mine closure claims conducted by CSIR-NEERI, Nagpur regarding reimbursement of claims under Final Mine closure Plan of 02 Mines of WCL as mentioned in Annexure -I for an amount of **Rs. 13,70,11,259/- (Thirteen Crore Seventy Lakh Eleven Thousand Two Hundred Fifty Nine Rupees only)** and balance amount at the end of final mine closure. After scrutiny of documents submitted by WCL and inspection report submitted by OSD, CCO, Nagpur, the Technical Committee of CCO (HQ), had recommended for reimbursement of Rs. 17,30,47,131/- **(Seventeen Crore Thirty Lakh Forty Seven Thousand One Hundred Thirty One Rupees only)** plus Interest accrued till the date fund release for the said projects. As per the approval of Competent Authority, I am directed that an amount of Rs. 17,30,47,131/- **(Seventeen Crore Thirty Lakh Forty Seven Thousand One Hundred Thirty One Rupees only)** plus Interest accrued till the date of fund release will be released as per the new guidelines issued by M/o Coal dated 29th May 2020.
